

Thai-Italian prepared signing MOU includes production, trading, and investing in agricultural

Retrieved from Infoquest, 11 November 2024.

Minister of Agriculture and Cooperatives revealing the discussion with H.E. Mr.Francesco Lollobrigida minister of agriculture, food sovereignty and forestry of the Italian Republic, which they are preparing MOU. The Deputy Prime Minister and MInister of Transport revealed that after discussing with executives with a number of Italian private companies, they were more interested in investing in Thailand. In addition, they had discussed investment approaches like an economic bridge project connecting the Gulf of Thailand - Andaman Sea (Chumphon-Ranong) or the "Land Bridge Project".

Foreign investment in Thailand continues to grow, which in the first 11 months reached 213 billion baht.

The Director-General of the Department of Business Development, Ministry of Commerce, revealed that during 11 months of 2024. There were 884 foreigners who were permitted to invest and conduct business in Thailand under the Foreign Business Act of 1999. In which, Japan ranked the 1st most investor, followed by Singapore, China, and the USA. These foreign business operations in Thailand, especially in the country's most investors, have helped transfer specialized knowledge and technology for Thai people.

Thai exports are strong and not falling, which grew up to 8.2% in November 2024.

Thai exports are forecasted to reach 5.2% in the whole year. In November 2024, the Director of the Office of Trade Policy and Strategy (OTPS) revealed that Thai's exports were worth 25,608.2 million US dollars, expanding for the 5th consecutive month. With the main driving factor being the export of technology products, especially computers, electronic equipment and components. This has grown at a high level, as the world's transition to a digital age.

ITALY

Alcohol-free and low-alcohol wines will be soon produced also in Italy: Decree presented

Alcohol-free and low-alcohol wine market: a fast-growing market, especially abroad, but one that Italian producers could not compete with. Although such products were already regulated in Europe, in Italy the current regulatory system prohibited calling a drink with an alcohol content of less than 8.5 degrees "wine". The draft presented by Minister Lollobrigida envisages production in non-DOC areas and the labelling of "dealcoholised" wines: it will be forbidden to increase the sugar content of the must and to add water or flavourings to the product.

ITA Airways, shareholders' meeting approves capital increase of EUR 325 million for Lufthansa

After about two years of on-and-off talks, Lufthansa is finally taking a minority stake in Ita Airways. The deal was agreed in late afternoon at a special meeting of shareholders, who approved the capital increase reserved for Lufthansa. The deal must be completed by 15 January, when Lufthansa will invest €325 million for 41% of the capital. The Extraordinary Shareholders' Meeting of Ita Airways also decided to amend the Articles of Association to include two representatives of the German group in the five-member Board of Directors.

Sixth instalment of €8.7 billion for Italy paid by the European Commission

To date, Italy has received a total of €122.2 billion of the €194.4 billion allocated to it under the Recovery Plan. The European Commission has disbursed a total of €6.9 billion in loans and €1.8 billion in grants to Italy, net of pre-financing, as the sixth instalment of the NRP. Italy's sixth payment request, covering 39 milestones and targets, was submitted on 28 June 2024. These include reforms in public administration, human resources, public procurement and tax administration, and social policy.

US Envoy-in-Waiting Blasts UN as Corrupt & Threatens Funding Cuts

Elise Stefanik, President-elect Trump's nominee for UN Ambassador, criticized the UN as "corrupt and antisemitic," threatening funding cuts. A staunch Israel supporter, Stefanik condemned the Human Rights Council and called for reforms. Critics, including former UN officials, view her nomination as opposing multilateralism. The U.S., contributing 22% of the UN's budget, may reduce support under Trump. Analysts predict heightened U.S.-UN tensions, prioritizing America-first policies while undermining global cooperation.






Amerigo Vespucci, the renowned Italian explorer and navigator, stands as one of history's most influential figures in the discovery and mapping of the New World. Born in Florence, Italy, in 1454, Vespucci's name is synonymous with the Americas—its continents named after him in honor of his contribution to the understanding of the western hemisphere.

Vespucci's voyages across the Atlantic were monumental in shaping the world's understanding of geography. Unlike Christopher Columbus, who believed he had reached the East Indies, Vespucci was one of the first to propose that the lands discovered by European explorers were part of a new continent. Through his explorations, he suggested that the lands he encountered were separate from Asia, marking a critical step in the identification of the Americas as distinct continents. His extensive accounts and letters, particularly his "Mundus Novus", contributed to the spread of this new geographical understanding.

Vespucci's influence was solidified when the German cartographer Martin Waldseemüller adopted the name "America" in 1507 for the new continent, derived from the Latin version of Vespucci's first name, "Americus." This was an honor that solidified Vespucci's legacy, forever associating his name with the Americas.

Though much of Vespucci's life is shrouded in mystery, with debates over the authenticity of some of his voyages, his contributions to early modern geography are unquestioned. His work helped to map the coastlines of South America, and his insights into the size and shape of the continents reshaped European knowledge, eventually influencing global trade, politics, and culture







VESPUCCI WORLD TOUR: ICONIC ITALIAN NAVY SAILBOAT DOCKS IN PHUKET FOR THE FIRST TIME



Phuket, 3 November 2024 - The Amerigo Vespucci, historic sailing ship and training ship of the Italian Navy, will dock in Phuket, Thailand for the first time, in Phuket, on November 5, the 27th stop on the World Tour, the third stop in South-East Asia; the stopover follows by just a few days the stop in the city of Belawan, in Indonesia.

Visiting aboard the Amerigo Vespucci ship docked in Phuket the Italian Minister of of Agriculture, Food Sovereignty and Forestry (MASAF) Francesco Lollobrigida and the Deputy Chief of Staff of the Italian Navy, Admiral Giuseppe Berutti Bergotto.

Since its departure from Genoa in July 2023, MASAF has chosen the Amerigo Vespucci as one of the platforms to promote the candidacy of Italian cuisine as UNESCO intangible heritage. During the Singapore stop, awards were given on board to the ambassadors of quality, in support of the candidacy.

The Amerigo Vespucci, guardian of the most ancient naval and seafaring traditions for over ninety years - is one of the most well-known symbols of Italy in the world. The initiative of the "Vespucci World Tour", strongly supported by the Minister of Defense Guido Crosetto, combines the traditional training activity of the Officer cadets and the promotion of the excellence of Made in Italy. The Vespucci is the emblem of the Navy and of Italy itself: following the maritime traditions, over the years it has contributed to the growth of the country's prestige. The ship left the Port of Genoa on July 1, 2023 to complete a round-the-world trip lasting about 2 years and brings with it the culture, history, innovation, science, research, technology, which make Italy a country, appreciated throughout the world.

The Welcome Ceremony will be held on November 5th at 6.30PM to welcome the Amerigo Vespucci ship in Phuket there will be the Italian Ambassador to Bangkok H.E. AVOIDING ILLEGAL NOMINEE STRUCTURES: COMPLY WITH THAI BUSINESS OWNERSHIP LAWS

The number of new business registrations in Thailand is landmark case involving a law and accounting firm in Phuket projected to surpass 90,000 this year, fuelled by a rebound in exports and tourism, alongside government stimulus initiatives in the final quarter.

There were 76,653 new business registrations in the first 10 months of 2024, a 2.18% increase compared to the same period last year. In October alone, 7,267 new businesses were registered, reflecting a 9% rise from the previous month. This growth is attributed to infrastructure development projects set to launch in the fourth quarter, recovering consumer spending and tourism, and the ongoing expansion of factories across various country regions.

However, Thailand's business ownership laws can be challenging for foreign investors, especially under the Foreign Business Act (FBA) restrictions. While using Thai nationals as nominee shareholders may seem like an easy way to bypass these restrictions, it's important to understand that this practice is illegal and carries severe consequences for all parties involved.

Let's look at the pitfalls of nominee structures, their risks, and the legal alternatives available to help you correctly establish your business in Thailand.

Recent Crackdowns on Nominee Offenses

In recent months, Thai authorities have ramped up enforcement against nominee structures under the Foreign Business Act (FBA), targeting arrangements where Thai nationals serve as nominal shareholders or directors to circumvent foreign ownership restrictions. On 10 October 2024, the Department of Special Investigation (DSI) announced the conclusion of a

that orchestrated nominee arrangements for approximately 60 companies.

These companies, operating in restricted sectors and holding land in violation of the FBA and the Land Code, caused significant economic harm. By using nominees, they not only bupassed legal requirements but also deprived the government of billions of Baht in tax revenue, further threatening national security. Following an extensive investigation, the DSI filed a complaint, and on 11 September 2024, the criminal court delivered its judgment, imposing severe penalties on the perpetrators.

The court sentenced 23 defendants, including Thai nationals, foreign investors, and implicated companies, to 10 years' imprisonment. Due to their cooperation with authorities, confessions, and lack of prior criminal records, the sentences were reduced to 5 years, suspended for 2 years, with 1 year of probation. Additionally, each defendant was fined THB 200,000, and all companies involved in nominee offenses were ordered to be dissolved. Thai nationals implicated in the scheme were explicitly prohibited from engaging in similar activities in the future.

To build its case, the DSI investigated key aspects of the nominee arrangements, including shareholding structures, decision-making authority, funding sources, and dividend distribution. Investigators uncovered evidence that Thai nominees were holding shares on behalf of foreign investors, with foreigners retaining actual control over company decisions and receiving preferential financial benefits. The companies often used foreign funds to purchase shares, further undermining the appearance of compliance



Fines and penalties for violators

What Are Nominee Structures, and Why Are They Illegal?

Nominee shareholding typically involves random Thai nationals holding a majority stake in a business on paper while foreign investors maintain actual control. In such arrangements:

- Nominees often do not invest their own funds.
- Nominees knowingly allow their name to be used to bypass ownership restrictions.
- Nominees participate in creating agreements that transfer control to foreign investors, or do they have the financial and educational qualifications to contribute to the company's operations.
- Nominees act as a "legal shield" with no genuine involvement in the business.

Penalties for Illegal Nominee Structures

These penalties are outlined under the Foreign Business Act B.E. 2542 (1999) and related laws.

Why Some Investors Resort to Nominee Structures?

Despite the risks, foreign investors often turn to nominee arrangements due to:

- 1. Ownership Restrictions: Limited foreign ownership in restricted industries (e.g., real estate, retail).
- Perceived Shortcuts: The assumption that nominee setups save time and effort compared to securing legal permissions.
- 3. Bad Advice: Misleading guidance from unqualified consultants who downplay risks or legality.

However, the Thai government has ramped up enforcement efforts, making it imperative for investors to seek compliant solutions.

It may be too late to restructure your company if investigations have begun.

Legal Alternatives for Foreign Investors

Thailand offers several lawful options for foreign businesses to establish operations.

In the first 10 months of 2024, 786 foreign investors were \(\) permitted to invest and conduct business in Thailand, comprising 181 investments through a foreign business license application. A further 605 cases either requested a certificate of business operation for foreigners through investment channels under the Investment Promotion Act, received permission under the Industrial Estate Authority of Thailand Act, or exercised rights in line with international treaties or agreements.

Most investments were in engineering services, auto parts and design services, installation, testing, repair, maintenance, and training services related to machinery and equipment, core software system services, and contract manufacturing


